Her experience includes marriage/partner, individual, and family counseling. She has conducted parenting classes using Common Sense Parenting by Boys Town Co. Her past work has included working for mental health agencies focused on children's mental health. Donna worked with the parents to help them understand their child's diagnosis and how to relate with their children. She has worked for the State of MT Children's Mental Health Bureau as a Wrap Around Facilitator and then as a Clinician overseeing services in state and out of state for Montana children. She has been an Associate Clinical Director overseeing staff and supervision of clinical services for group homes and community based services. She worked with therapeutic foster youth and youth involved in the Youth Probation. She has worked in conjunction with the Department of Family Services and successful in keeping the majority of families together. In Washington state, she was the Clinical Supervisor of a branch that worked with adults and children with severe emotional disturbances. Currently she works as the school counselor for a local school where she teaches Social Emotional Learning for the students, provides other counseling as needed, and regular counselor duties.
